## DID YOU KNOW?

*You can donate part of your Georgia state taxes to Global Village Project.*

The GA Tax Credit Program allows you to provide scholarships for our students **at zero net cost to you**. As a participant, you'll pledge funds that would otherwise be spent on your state taxes to helping cover the cost of GVP students' tuition and our COVID-19 GVP family support.

By signing up through the Apogee Scholarship Fund, you can pledge to donate any amount you want up to the max based on your filing type. After the State of Georgia approves all or part of your pledge, you send a donation for the approved amount to GVP's scholarship fund at Apogee. The following year, you'll qualify for a dollar-for-dollar state tax credit for the amount of your donation!

You may also qualify for **double the tax benefit**: In addition to the dollar-for-dollar state tax credit, you may also be able to count your gift as a charitable deduction on your federal taxes. Remember that in the meantime, you will need to fulfill your donation out-of-pocket.

## HOW TO SIGN UP



1. *Establish or estimate how much you pay in state taxes each year. Decide the amount you'd like to donate. The max allowed for your filing type is:*

- \$1000 for single
- \$1250 for separate married
- \$2500 for joint married
- \$10,000 for pass-through (LLCs or S-Corps)

2. *Go to [Apogee123.org](https://Apogee123.org) and click "Get Started Apply Today".*

3. *Choose your filing type and fill in your contact information.*

4. *Select [Global Village Project](#) as the recipient school and fill in your pledge amount.*



*Click [submit](#), and you're done! 2 minutes is all it takes to sign up.*



## What Comes Next
